# 1. Meeting called to order by Chairman Dressler @ 4:00 pm. Welcome to all present.

2. Roll Call

## 8. Old Business

a. The Board discussed the proposed mold remediation; repairs; remodels and upgrades to District residence/office. The General Manager reported on the progress to date and reviewed Jason Grant's design and the "Scope of Work" for bidding process.

# 9. New Business

- a. The Board authorized reimbursement of temporary housing expenses (apartment rent; gas/electric usage; storage rent; moving expenses) for District G.M.; due to conditions (mold/structural problems) at District residence, and to allow for proposed mold remediation; repairs, and upgrades; not to exceed \$3,000/mo, effective June 1, 2012 and to continue until the completion of the project. Motion by McClure, second by Chyla, all ayes, motion carried.
- b. The Board approved a 2% "cost of living" salary increase for District Staff; effective July 1, 2012. Motion by Chyla, second by McClure, all ayes, motion carried.
- c. The Board approved an increase of casket "interment fee" of \$67.00. Effective July 1, 2012. Motion by Chyla, second by McClure, all ayes, motion carried.
